# 16-19 BURSARY FUND FACT SHEET 2023/24

# Young People in Care

## What is the 16-19 bursary fund?

It is a scheme to help young people facing financial hardship to stay in full-time education.

#### How much will young people receive?

Those most in need will be eligible for a bursary of  $\pounds 1,200$  a year. This includes young people in care and care leavers.

#### What is the criteria for eligibility?

Young people in care and care leavers must be:

- I6 years and over
- Following a part time or full time course funded by the Education Funding Agency (EFA) or the European Social Fund

#### Who is not eligible for the Access Bursary Funding?

- Young people in care and care leavers under 16 years of age or over 19 years of age on 31/08/23
- Young people in care and care leavers who do not meet the EFA residency criteria. (In order for a learner to be eligible for EFA funding, he/she must have the legal right to be resident in the United Kingdom at the start of the programme. All 16-18 year-old learners (including unaccompanied asylum seekers) who are placed in the care of social services meet residency criteria.

#### How is the scheme operating in Plymouth?

- The funding for the scheme is provided by the EFA.
- Most Plymouth Schools and Academies have pooled their grants and, alongside Plymouth City Council, have designed a collaborative scheme

#### Are all the providers involved in this collaborative scheme?

 No. Five providers are operating their own scheme: City College Plymouth and Plymouth College of Art, Coombe Dean, Plymstock, Hele's and UTC Plymouth

# What happens if a young person in care or a care leaver attends any of those five providers?

 All five providers will also give a bursary award of £1,200 to young people in care and care leavers, as it is statutory.



### How do young people in care and care leavers apply for their bursary?

 A simple application form was available from the Head of Sixth-Form in September. This needs to be completed and returned to the Local Authority via the sixth form (for the collaborative scheme)

#### How will young people in care and care leavers receive their Bursary?

In the collaborative scheme, payments will be made to students monthly in arrears by BACS

# Do young people in care and care leavers automatically receive their bursary once they have applied?

No, continued payments will be subject to good attendance, behaviour and standards of work.
